- 001-2020 Appropriation Ordinance Amended Budget Summary – All 2020 Budget Funds
- 002-2020 An Ordinance of the Township of Hanover extending the real estate tax deadline, reducing the penalty period per centum, and authorizing future extensions whereof within the Township of Hanover
- 003-2020 An Ordinance of the Township of Hanover establishing customer only limited parking spaces on the west side of Lee Park Ave at the intersection of Oxford Street in the Township of Hanover
- 004-2020 An Ordinance of the Township of Hanover approving the agreement and participation of the Police Department of Hanover Township with the Luzerne County Drug Task Force, Commonwealth of PA, Office of the Attorney General and Luzerne County District Attorney's Office
