

2021 ORDINANCES

- 001-2021 An Ordinance with the Borough of Sugar Notch approving the Intergovernmental Cooperation of Hanover Township Fire Department and the Borough of Sugar Notch and delegating fire protection of Sugar Notch Borough to Hanover Township.
- 002-2021 An Ordinance authorizing creation of a Covid-19 sick bank providing parameters and authorizing administration
- 003-2021 An Ordinance establishing a Local Economic Revitalization Tax Assistance (LERTA) program within the Township of Hanover located on approximately 38-539 acres of land being a portion of the Earth Conservancy – BLISS I, BLISS II and BLISS III sites in Hanover Township, Newport Township and Nanticoke City
- 004-2021 An Ordinance authorizing the placement of a “yield to oncoming traffic” sign at the existing Elma Drive eastbound approach to the W. St. Mary’s Rd intersection and providing penalties for violations thereof
- 005-2021 An Ordinance requiring permitting for short term rentals and defining said terminology.
- 006-2021 An Ordinance prohibiting parking during school hours and during the school year on the south side of Colley Street for a distance of two hundred seventy-nine feet (279’) in front of the Lyndwood Learning Center, and authorizing the installation and maintenance of no parking signs and providing penalties for violations thereof
- 007-2021 An Ordinance appropriating funds set forth for the 2022 Budget

- 008-2021 An Ordinance prohibiting parking during certain hours and on certain days on both sides of Woodbury Street for a distance of seventy five feet (75') and also authorizing the installation and maintenance of no parking from here to corner signs and providing penalties for violations thereof.
- 009-2021 An Ordinance imposing a mercantile and business privilege tax at one mill for wholesale and brokers and one and on-half mill for retail, restaurant, hawkers, peddlers, professions and contractors for the year 2022
- 010-2021 An Ordinance imposing an Earned Income Tax of one (1%) per centum for the year 2022
- 011-2021 An Ordinance imposing a Local Service Tax for the year 2022 in the amount of fifty-two (\$52.00) dollars on the privilege of engaging in an occupation within the Township pursuant to Act 7 of 2007 and Ordinance 005-2007, the Hanover Township Local Service Tax
- 012-2021 An Ordinance imposing a Realty Transfer Tax of one (1%) per centum for the year 2022
- 013-2021 An Ordinance fixing the tax rate for the year 2022 at 5.5 Mills
- 014-2021 An Ordinance amending the zoning map of the Township of Hanover by changing the Zoning District Classification of approximately 16.774 acres of vacant land from C-2 and R-2 to R-3 contained within parcel no. 2519NW1-017VAR000 and generally bounded in park by Plymouth Avenue, West End Road and the Delaware & Hudson Railroad
